Biographical Sketch

C. Howard Sweatt (1909-1993) was a leader in the Florida citrus industry, especially the citrus canning industry. Born in Nashville, Tennessee, Sweatt moved to the Central Florida area in 1942; he became the owner of BESCO Products Company in Orlando in 1946. From 1947-1948, he was President of the Florida Canners League, and then served as the President of the Florida Canners Association from 1949-1950. In 1951, he sold his BESCO cannery and started at Fosgate Citrus Concentrate Cooperative as their sales manager. He left Fosgate in 1957 and eventually joined Golden Gem Growers in 1962 as their marketing director. Because of his position at Golden Gem, Sweatt was one of the original founders of Citrus Central Inc. He joined the company in 1968, when Citrus Central took on all marketing responsibilities for Golden Gem and other affiliated companies. In 1974, Sweatt retired from the citrus industry. In addition to his leadership in the citrus industry, Sweatt was a leader in many organizations around Orlando such as the Rotary Club, Central Florida Sales Executive Club, and the Country Club of Orlando.

Scope & Content Note

Sweatt's papers are arranged in five series – Canning and Processing, Companies (he worked at), Foreign Trade, Marketing, and Personal. The materials reflect his professional life, with some photographs and documents of his personal life. Sweatt worked at several Citrus focused companies as well as volunteered at several Citrus canning associations. He was influential in taking the Florida orange juice trade overseas, especially to Japan, and this is reflected in the Foreign Trade series. The files contain correspondence, reports, brochures, and studies. The Canning and Processing series includes, reports, correspondence, research files, and information about the soft serve industry at the time. Marketing files are about marketing various aspects of the citrus industry. Within the Company series, for Golden Gem, there are membership newsletters dating from 1967 to 1984, and stockholder meeting files from the 1960's and 1970's.
