# **Historical Sketch:**

The development of Holly Hill near Davenport, Florida began in December 1919 as part of the Holly Hill Grove and Fruit Company, a subsidiary of the Wilson and Toomer Fertilizer Company. Like other Florida land development companies during the 1920s, the Holly Hill Grove and Fruit Company packaged together the sale of house lots with citrus grove lots. Soon, the deal shifted to if someone bought a grove lot, they would receive a lot in town. Holly Hill Grove and Fruit Company also built multiple amenities in Davenport including the Holly Hill Inn in 1920 as well as the Holly Hill Golf and Country Club in the mid-1920s.

In 1927, the Holly Hill Grove and Fruit Company formed Holly Hill Fruit Products, Inc., and soon after its creation, Holly Hill Fruit Products, Inc. bought its business as a citrus fruit marketing company and its trademarks from Holly Hill Grove and Fruit Company. However, Holly Hill Citrus Growers Association started selling citrus as an agent of Holly Hill Grove and Fruit Company, thus violating the agreement and causing Holly Hill Fruit Products, Inc. to file a successful lawsuit against Holly Hill Grove and Fruit Company. Due to the lawsuit, the effects of the Great Depression, and other economic and ecological disasters in Florida, Holly Hill Grove and Toomer. The country club that had been built also closed in the 1930s and was turned into housing and citrus groves. In contrast, Holly Hill Fruit Products, Inc. flourished despite these same issues and continues to exist to this day.

#### **Provenance Statement:**

Based on Professor Thomas Mack's unpublished manuscript "Documented History of the Florida Citrus Archives," the materials are presumed to have been donated by Robin Hooker, a graduate from Florida Southern College's Citrus Institute, who had found the materials as he went through his father Glenn Hooker's citrus memorabilia. However, it is unknown exactly when the materials in this collection were donated to the Citrus Archives. The Thomas B. Mack Citrus Archives were transferred to the Roux Library in 2005 then to the McKay Archives Center in 2009.

## Notes to Researchers:

The original order was unable to be determined because there is little documentation from the original accessioning. Furthermore, the date range for the collection is an approximation based on the few dated photographs as well as company history.
